

# The big changes

Limits on **fixed term contracts** (duration & number of potential renewals)

New definition of who is an **employee** and changes to **sham contracting** provisions

New definition of a **casual employee** & changes to casual conversion rights

New right for employees to **disconnect** from work

New procedural requirements about responding to flexible working requests

New "same job, same pay" rules impacting on labour hire arrangements

Respect@Work and the positive duty to avoid sexual harassment, discrimination etc
